- Have a storefront or commercial location outside of the residence for resale of chicks
- Have and provide either the tax ID number or federal ID number
- Intention of purchasing a minimum of \$1,000 in chick orders per year for resale – accounts that fail to meet the minimum will be reviewed and may not qualify for dealer status the following year / hatch season

If the above qualifications are met, please submit the application via fax at (616) 772-2969 or email to office@townlinehatchery.com for review. One of our staff members will notify you of the status after reviewing the application and if approved, further instructions and price lists will be provided along with a new dealer packet.
